

**Legacy High School Girls Soccer Booster Minutes**  
**June 8, 2015**

Zanthia Price called the meeting to order. Meeting held at Zion Lutheran Church. Those attending included: John Baumgartner, Laurie Baumgartner, Patty Schock, Tanya Guthmiller, Zanthia Price, Sandra Domagala, Dorinda Sailer, DeAnn Hilz, and Coach Tom Marcis.

**Secretary's Minutes:** Zanthia presented copy of meeting minutes to those needing to review. Laurie Baumgartner made motion to approve minutes as written, DeAnn Hilz seconded. Motion approved.

**Treasurer's Report:** Dorinda Sailer reported the Dakota Community account has \$6,146.92 after banquet expenses. She reported the school account has \$2,317.16 but \$1,070 is for coach fee and \$298 for video camera cost. A general breakdown of the year included: Booster fees \$1,260.00; Donations/Sponsorships \$2,300.00; Raffle Revenue \$2,395.00; sock revenue \$684.80; Laundry Cards \$880.00; Applebee's Revenue \$1,528.00; Misc. Expenses (-\$1,941.45); Banquet Cost (-559.40).

**Committee Reports:**

**Car Wash:** Boys and Girls Soccer will both work the car wash and split profits; to be held July 25, 2015 at both north locations (Gateway and Yorktown) from 9-4:30. Plan will be to have sophomores at one location, juniors at the other and freshman will be placed at both locations. Laurie Baumgartner and Patty Schock will coordinate. Plan is for boosters to provide pizza for the workers.

**End of Season Banquet:** Laurie reported everything went well.

**Booster Rule Changes Bank Accounts:** Zanthia, Dorinda, and newly elected Treasurer will determine a time to close current Dakota Community account and open a new account for tax exempt status.

**Summer Camp:** Tom reported he likely won't be able to be at the Soccer Camp due to personal reasons. Zanthia asked if anybody that reported they would help work the camp was unable to attend; nobody reported they wouldn't be able to attend. **Concessions:** John Baumgartner reported on the concession committee; he asked the group how many events the Girls Soccer Booster wants to work - discussion held and John told to use own judgement in regards to number of events selected and once this is determined, the group will determine the number of events each athlete and parent needs to work.
